



## Waiver and Release of Liability

I, individually or I/we as parent(s) and/or natural/legal guardian(s) of my/our child understand and agree to the following provisions.

**(1) RELEASE FROM LIABILITY:** I hereby release and discharge Girl Scouts Western Oklahoma, Inc. (“GS West OK”) and its employees, volunteers, representatives and all other agents associated with GS West OK from any and all liability, claims, demands or causes of action that I may hereafter have for injuries or damages arising out of GW West OK’s transportation of me and/or my participation in any camp activity, including but not limited to, camping, a challenge course, high/low ropes course, horseback riding, archery, sling shots, boating, swimming, canoeing, tubing, and other outdoor activities, even if caused by the negligence or other fault of GS West OK, its employees, volunteers, representatives, agents, or other camp participants. This release and waiver of liability shall be binding on the my heirs, representatives, dependants and successors in interest.

**(2) COVENANT NOT TO SUE:** I further agree that I will not sue or make a claim against GS West OK, its employees, volunteers, representatives, agents, or its national organization for damages or other losses sustained as a result of GS West OK’s transportation of me and/or my participation in any camp activity including, but not limited to, the activities set forth in Paragraph 1 of this Agreement.

**(3) INDEMNIFICATION AND HOLD HARMLESS:** I also agree to INDEMNIFY and HOLD GS West OK HARMLESS from all claims, judgments, and costs, including but not limited to attorneys’ fees, and to reimburse them for any expenses whatsoever incurred in connection with an action brought as a result of my participation in any camp activities, including but not limited to those activities named in Paragraph 1 of this Agreement.

**(4) ASSUMPTION OF THE RISK:** I understand and acknowledge that camp activities, including but not limited to the activities set forth in Paragraph 1 of this Agreement, are inherently dangerous and I expressly and voluntarily assume the risk of death or other personal injury sustained while participating in camp activities whether or not caused by the negligence or fault of GS West OK, its employees, volunteers, representatives, and agents.

**(5) LIMITATION OF WARRANTY:** I understand that no warranties or representations of any kind have been made by GS West OK, its employees, volunteers, representatives, and agents regarding any camp activity or equipment used to participate in any camp activity.
